



## COMPLETE LIST OF DOCUMENTS TO PROVIDE FOR THE CREATION OF A COMPANY (SARL, SA. GIE, SUARL)

- 1. One (1) copy of the Identification Card (ID or passport) of the CEO and the shareholders or partners (and of employees eventually, or one (1) copy of certificate of birth);
- 2. Five (5) copies of actual state of the company / or statement of court;
- 3. one (1) copy of the notified statement of subscription and of payment;
- 4. two (2) copies of contract of lease or two (2) copies of the title of the property or of the certificate of the property;
- 5. One (1) statement on contract signed by the executives of the administrators, or associates kept indefinitely, and personally kept responsible completed in a deadline of 75 days, starting from the registration; registration done by sending 1 recent police record (less than 3 months old) or any other document as a proof of good ethic;
- 6. One (1) copy of the certified, in accordance with the executive, list of administrator or partners kept indefinitely and personally responsible having all powers to start the company;
- 7. One (1) legalized mandate in case of deposit of the document by a proxy (except notary);
- 8. A plan of localization of the place where the activities will be exercise.

### Physical Presence (Individual companies)

- 1. One (1) copy of a primary ID (or passeport) for citizens, or consula card for non-ctizens of the executive.
- 2. One (1) copy of the Birth certificate of the executive.
- 3. two (2) copies of leasing conract or two (2) copies of property title or of ownership certificate.
- 4. One (1) Statement on honor signed by the requestor, completed within a 75 days deadline starting from the registration; registration done by sending 1 recent police record (less than 3 months old) or any other document as a proof of good ethic.
- 5. One (1) certificate of residence;
- 6. One (1) copy of certificate of marriage or a copy of the family book;
- 7. One (1) penal authorization prior to any activity;
- 8. In case of designation of a person in charge of the company, provide:
  - One (1) copy of a primary identification;
  - One (1) Statement on honor signed by the requestor, completed within a 75 days deadline starting from the registration; registration done by sending 1 recent police record (less than 3 months old) or any other document as a proof of good ethic
  - One (1) certificate of residence.
- 9. A project of localization of the activity site.
